AMENDMENT TO GOVERNMENT REGULATION NUMBER 46 OF 2015 ON ADMINISTRATION OF OLD-AGE SECURITY PROGRAM

BY THE BLESSINGS OF ALMIGHTY GOD

PRESIDENT OF THE REPUBLIC OF INDONESIA.

Considering: a. that by considering conditions of national employment and aspirations developed in society is required to be regulated on changes in providing old-age security benefits for Members who have stopped working;

- that based on the consideration as referred to in point a, it is necessary to issue a Government Regulation on Amendment to Government Regulation Number 46 of 2015 on Administration of Old-Age Security Program;
- Observing: 1. Article 5 section (2) of 1945 Constitution of the Republic of Indonesia;
 - 2. Law Number 40 of 2004 on National Social Security System (State Gazette of the Republic of Indonesia of 2004 Number 150, Supplement to the State Gazette of the Republic of Indonesia Number 4456);
 - Government Regulation Number 46 of 2015 on Administration of Old-Age Security Program (State Gazette of the Republic of Indonesia of 2015 Number 156, Supplement to the State Gazette of the Republic of Indonesia Number 5716);

HAS DECIDED:

To issue:

GOVERNMENT REGULATION ON AMENDMENT TO GOVERNMENT REGULATION NUMBER 46 OF 2015 ON ADMINISTRATION OF OLD-AGE SECURITY PROGRAM.

Article I

The provisions of Article 26 of Government Regulation Number 46 of 2015 on Administration of Old-Age Security Program (State Gazette of the Republic of Indonesia of 2015 Number 156, Supplement to the State Gazette of the Republic of Indonesia Number 5716), are amended to read as follows:

Article 26

- (1) JHT benefits are paid to Members if:
 - a. Members reach the retirement age;
 - b. Members suffer from a total permanent disability; or
 - c. Members pass away.
- (2) JHT Benefits for Members who reach retirement age as referred to in section (1) point a are provided to members.
- (3) JHT Benefits for Members suffer from total permanent disability as referred to in section (1) point b are provided to Members in accordance with the provisions of legislation.
- (4) JHT Benefits for Members who pass away as referred to in section (1) point c before they reach their retirement age are provided to beneficiaries as referred to in Article 23 section (2).
- (5) Further provisions regarding the procedure and requirements of JHT benefit payment as referred to in section (1) are regulated by a Ministerial Regulation.

Article II

This Government Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Government Regulation in the State Gazette of the Republic of Indonesia.

AMENDMENT TO GOVERNMENT REGULATION NUMBER 46 OF 2015 ON ADMINISTRATION OF OLD-AGE SECURITY PROGRAM

I. GENERAL

JHT is a long-term program which is aimed to provide guarantee on the availability of funds for workers when they are no longer productive. However, in a certain condition, the JHT funds, which are partly collected from workers, are also necessary to sustain their life even though they remain in their productive age.

Regulation of the Government of the Republic of Indonesia Number 46 of 2015 on Administration of Old-Age Security Program, as the implementation of Law Number 40 of 2004 on National Social Security System has not accommodated the national employment conditions in its progress. In particular, it has not accommodated regulations on the JHT benefits payment to who stop working because, among others, Members resign, get termination of employment, or leave Indonesia for good.

Based on the considerations, it is necessary to amend Government Regulation Number 46 of 2015 on Administration of Old-Age Security Program.
